"STUDENT TALENTS" THE COMPETITION REGULATIONS

§1

General terms

- 1. The Regulations define the rules and procedure of granting rewards in the competition "Student Talents", hereinafter referred to as 'the Competition'.
- 2. The aim of the Competition is to promote and reward students foreigners, who have artistic, organizing, dancing or other talents or who have been successful in innovative, artistic, social, sports activities or as young entrepreneurs.
- 3. The organizer and the founder of the awards in the Competition is the Foundation for the Development of Education ESCOLA, address: 52 Revolution of 1905' street, 90-213 Lodz.
- 4. The Organizer is the administrator of personal data provided by the participants of the Competition. The contact details of the Personal Data Inspector are the same as the contact details of the Organizer: Foundation for the Development of Education ESCOLA, address: 52 Revolution of 1905 ', 90-213 Lodz, drukcsm@ahe.lodz.pl
- 5. The present regulations specify the terms and conditions of the Competition, which the participant accepts by submitting the application of the Competition.

§2

The Participants of the Competition

The participants of the Competition may be the students of legal age - foreigners (non-having Polish citizenship), from public and non-public Universities of Lodz, from all fields and degrees of study.

§3

Terms of participation in the Competition and selection of the Winners

- 1. The candidates submit independently their application to participate in the Competition.
- 2. It is allowed to submit individual persons or teams.
- 3. Applications must be submitted by email to the e-mail address: kontaktcsm@ahe.lodz.pl, along with the appendix described in **§3.4**.
- 4. The appendix to the candidate's application should include the CV of the candidate (or members of the team of candidates) maximum one A4 page, a brief description of the talent maximum one A4 page, and:
 - a link to the audio/video recording stored/published on YouTube, Google drive, Vimeo, or other internet service, where the posted materials show the use of the talent (audio, video, photos, etc.)

- a file (of any format) presenting the use of the talent.
- 5. Applications must be submitted by June 4, 2021.
- 6. Applications submitted differently than in the way defined in **§3.3** will not take part in the Competition.
- 7. The Panel of Judges, established by the Organizer, will select from all the applications the three Winners, who will present their talent during the Open Your Lodz Gala, which will take place on June 11, 2021, in Lodz, in the place indicated by the Organizer.

or

- 8. The Winners will be selected by the Panel of Jury according to the following criteria, for which points will be awarded:
 - a) a creative and plastic description of the talent in the application (0 5 points),
 - b) whether the talent was previously recognized, e.g., as part of other national or international competition or festival (0 5 points),
 - c) the effect of talent on the social setting / academic community (0 5 points)
 - d) whether the talent fits in with the idea of multiculturalism in Lodz, in other words whether this talent can connect students and residents of the city of Lodz (0-5 points).

§4

Winners' Rewards

- 1. The three Winners of the competition will receive rewards as follows:
 - a. a voucher in the amount of PLN 400.00 to be used at the Hotel SPA Magellan in Bronisławów,
 - b. a voucher in the amount of PLN 500.00 to be used in the Manufaktura Shopping Center,
 - c. Tourist Cards,
 - d. souvenirs from the Foundation for the Development of Education ESCOLA.
- 2. The Organizer declares that the total value of all the rewards that every Winner will receive, does not exceed 2,000.00 PLN, therefore the received reward is an exempt from personal income tax, in accordance with the applicable regulations.
- 3. The rewards are not exchangeable for a cash equivalent.
- 4. The decisions of the Panel of Jury are final. There is no possibility of proceeding an appeal procedure against them.

§5

The stages of the Competition

- 1. The Competition "Student Talents" organized by the Foundation for the Development of Education ESCOLA has three stages:
 - a. the first stage includes the independent application of candidates to the Panel of Jury, established by the Foundation for the Development of Education ESCOLA,
 - b. the second stage includes the Jury's assessment of the applications submitted to participate in the Competition and the selection of three Winners, who will receive invitations to take part in the Open Your Lodz Gala,
 - c. the third stage includes the Open Your Lodz Gala, which will take place on June 11, 2021, during which the rewards will be officially announced and awarded.

§6

Final conditions

 The participation in the Competition "Student Talents" (started by submitting the application) is tantamount to the acceptance of these regulations and the consent for the free use of the participant's image - in particular in the form of a photo, audio-visual recording or another form, during the Open Your Lodz Gala - by the Organizer of the Competition and the University of Humanities and Economics in Lodz (26 Sterling street, 90-212 Lodz) in promotional materials, particularly on websites and social media, in printouts and leaflets.

- 2) Participation in the Competition is tantamount to consent to the processing of personal data for the purposes of the Competition (in accordance with the Act of May 10, 2018 on the protection of personal data (Journal of Laws of 2018, item 1000) and in accordance with the Regulation of the European Parliament and Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (GDPR).
- 3) Providing the consent for processing the personal data is voluntary, but it is necessary for the participant to be able to participate in the Competition. The participant's personal data will be processed only for the purpose of settling the Contest, covered by the regulations for the period of time necessary to settle the Contest. Every participant has the right to request the access to personal data from the Administrator, to rectify it, delete it, limit processing, as well as the right to transfer data and to object to processing. Every participant has the right to withdraw consent to the processing of personal data that was given to the Administrator. Withdrawal of consent does not affect the lawfulness of the processing that was carried out before its withdrawal. Every participant has the right to lodge a complaint with the Supervisory Authority, which is the President of the Office for Personal Data Protection (from May 25, 2018). All those rights affecting the processing the personal data may be executed by submitting a statement with using the contact details of the Administrator or the Personal Data Inspector.
